HOLT REUNION

Time flies by! In just a little over three months, we will be meeting in Hampton, Virginia. The reunion dates are May 3 - 6, 2000 at the Holiday Inn & Conference Center, Hampton, VA. Make your reservations by calling 1-800-842-9370 or 1-757-838-0200. Identify yourself as being with the USS HOLT (DE 706) reunion group to take advantage of the \$70.00 per night room rate (single or double). Taxes of 10% will be added. Your reservation must be guaranteed with a credit card or a one night deposit, refundable if canceled three days prior to the arrival date. The Holiday Inn's address is 1815 West Mercury Blvd, Hampton, VA 23666-3229 and their FAX number is 1-757-838-4964. If you wish to arrive early or stay late, this room rate is good for three days prior to the reunion and up to three days after the reunion. SCHEDULE OF EVENTS

Wednesday, May 3, 2000 - arrival Day. Hospitality Room will open about noon.

Thursday, May 4th - Visit the MacArthur Memorial in downtown Norfolk.....a short drive thru "Old Norfolk".....Board the "Spirit of Norfolk" for a two-hour luncheon cruise of Norfolk harbor.....re-board the bus for a short visit to the MacArthur Center (a new shopping mall) then return to the hotel. AN INTERESTING STORY

During the course of World War II, many people gained fame in one way or another. One man was Butch O'Hare. He was a fighter pilot assigned to an aircraft carrier in the Pacific. One time his squadron was assigned to fly a particular mission. After he was airborne, he looked at his fuel gauge and realized that someone had forgotten to top off his fuel tank. Because of this, he would not have enough fuel to complete his mission and get back to his ship. His flight leader told him to leave the formation and return to the carrier. As he was returning, he spotted a flight of Japanese planes heading for the fleet. With all the fighter planes gone, the fleet was almost defenseless. His was the only opportunity to distract and divert the enemy planes. Single-handedly, he pressed home the attack on the enemy aircraft.

Finally, the Japanese squadron broke off the attack. Butch O'Hare and his plane, both badly shot up, successfully limped back to his carrier. He told his story, but not until the film from the camera on his plane was developed, did they realize the extent he went to, to protect the fleet.

He was recognized as a hero and given the nation's highest military award. And, as you might know, Chicago's O'hare airport is named after him.

Prior to this time, in Chicago, there was a man named Easy Eddie. He worked for a man named Al Capone. Al Capone was not famous for anything heroic, but he was notorious for the murders he committed and the many illegal things he had done.

Easy Eddie was Al Capone's lawyer and he was very good at his profession. In fact, because of his skill, he was able to keep Capone out of prison. To show his appreciation, Al Capone paid him very well. He not only earned big money, he would get extra things, like a residence that covered a city block of Chicago. The house was surrounded by a fence and contained all the conveniences of the day, including a staff to maintain the place.

Easy Eddie had a son. He loved his son and gave him all the best things while the boy was growing up; clothes, cars and a good education. And because he loved his son, he tried to teach him right from wrong. But one thing he could not give his son was a good name.

Easy Eddie decided that this was more important than all the riches he had. So, he went to the authorities in order to rectify the wrong he had done. In order to tell the truth, it meant he would have to testify against Al Capone, and he knew that Capone would do his best to have him killed. But he wanted most of all to try to be an example and to do the best he could to give his son back a good name. So he testified against Capone. Within a year, he was shot and killed on a lonely Chicago street.

This sounds like two unrelated stories, but Butch O'Hare was Easy Eddie's son.
